POLICY NAME: Faculty, Staff & Student Participation in Institutional Governance

POLICY TYPE: Board

ISSUE OR STATEMENT OF PURPOSE: The Board of Trustees recognizes that participation by faculty, staff and students in policy development provides an opportunity for valuable contributions, helps to maintain open lines of communication among Board, administration, faculty, and students, and ensures broad consideration of mutual concerns for the continued development of Erie Community College.

NEW OR EDITED POLICY: Edited Policy III-B

POLICY:

The Board of Trustees authorizes the faculty, staff, and students to develop organizational structures which provide for their participation in policy development.

- A. The purpose of the aforementioned organizations shall be to establish mechanisms for providing communication with, and advice to, the President of the College and, through the President, to theBoard of Trustees on institutional matters other than wages, hours and working conditions which are typically part of the collective bargaining process.
- B. The by-laws of such organizations, which shall be subject to approval by the President of the College and the Board, shall be consistent with the by-laws, mission and goals of the College and shall provide for:
 - a. Election or appointment of committees and definition of their responsibilities.
 - b. Procedures for the calling and conducting of faculty or student meetings and elections.
 - c. Provision for other matters or organization or procedure which may be essential to the committees.



POLICY NAME: Faculty, Staff & Student Participation in Institutional Governance -- Continued

- C. The College Senate and other such organizations shall have a specific role in providing to the President of the College recommendations relating to educational programs and standards. Among examples are matters relating to:
 - a. credit course offerings;
 - b. standards of instruction, including grading practices and course descriptions; and
 - c. admissions and graduation requirements

The recommendations of the governance committees in these areas, shall be forwarded to the President of the College, and the President, will determine what will be presented to the Board of Trustees.

D. The Student Government Association and appropriate committees shall be jointly responsible with the administration and representatives of the faculty for recommendations on the formulation of policy relating to student activities and student discipline.
