POLICY NAME: Elimination of Academic Programs

POLICY TYPE: Board

ISSUE OR STATEMENT OF PURPOSE: The College seeks to comply with the current State University of New York Policy Handbook policy on Program Deactivation and Discontinuance in discontinuing or deactivating degree and certificate programs.

Definitions:

Deactivation of admissions means that no new students will be admitted to the degree program. Current students may continue in the program and the degree may still be awarded.

Discontinuation of a degree program removes it from the NYS Education Department Inventory of Registered Programs. Students may no longer be enrolled in the program and the degree may no longer be awarded.

Typically, admissions are deactivated first. The currently enrolled students are given several years (typically 3) to graduate prior to the discontinuation of registration of the program. It should be noted that programs are registered separately if offered on more than one campus.

NEW OR EDITED POLICY: Edited Policy IV-A-10

POLICY:

Decisions to deactivate admissions are approved by the President. Decisions to discontinue registration of a program are approved by the Board of Trustees. The discontinuation of registration will include review of recommendations from College Senate, the bargaining unit, and College administration. Actions to deactivate admissions or discontinue registration must be made separately for each campus.
